FILM FANS WERE REELING last night at the shock announcement that two of the screen's biggest idols, ANGELINA ADAMS and EDWIN EASTWOOD, have broken off their engagement and cancelled their much-publicised wedding plans. The decision is said to have been made by Mr. Eastwood, amid rumours that he has been seeing several other women in recent months. An agent for Miss Adams announced last night that her studio, Starstruck Pictures, would be taking action against Mr. Eastwood's studio, Silverscreen, citing

defamation of character and subsequent loss of earnings. However, Miss Adams' agent was quick to add that "while the financial settlement is right and necessary, it will in no way compensate for the personal anguish and heartbreak that Miss Adams is suffering due to the callous treatment and infidelity she has suffered at the hands of her former fiancé."

SYNOPSIS

The Court of the Exchequer

The time is 10 o'clock and the court is preparing for the first case of the day. The court will hear the case of Angelina who is suing Edwin for breach of promise. The Usher advises the jury of the need for them to give bias-free decisions. Despite this lecture Edwin has to endure a torrent of abuse from the jury when he enters court. However, it soon appears from his attitude that he is by no means above reproach. Edwin explains his youthful adoration for Angelina but that he has become bored with her and has now fallen in love with someone else. The jury are in no mood to accept this explanation. When the Learned Judge appears, he explains how well qualified he is to try this case, as he himself became a Judge by promising to marry 'the ugly, elderly daughter' of a rich attorney, only to 'throw her over' when he reached his position as a judge. (Is this really going to be an un-biased trial?)

The arrival of Angelina, accompanied by four of her most ardent fans, has an electric effect on the entire courtroom, not least on the jury and the Judge! Council for the Plaintiff then presents the case for the prosecution and despite a few basic errors, (mistaking Burglary for Bigamy!), the jury are obviously on his side.

The final solution arrives when the Judge, tired of the proceedings, loses his patience and dismisses the court, declaring that he will marry Angelina himself, an idea readily accepted by the lady in question, the jury and the court in general.

SAMANTHA GRANT



MUSICAL DIRECTOR ROBERT DRYWOOD

One year they took Trial by Jury to 45 Co-op Social clubs across Kent and south-east London. CHOREOGRAPHER/ PAMELA HAYFIELD WARDROBE

Needlework has been Pam's life for over 50 years. She learnt her trade from the age of 12 when she went to a technical school for Needlework and Art. For the past 15 years since she joined the Society she has not only had various principal and chorus parts, but for most of the shows has designed and made many of the costumes. Trial by Jury, set in the 1930s has been a little easier than some shows as many of the clothes from that time have come full circle from that style. As always, hats have been the most difficult item to obtain.

Dudley Gore





Samantha Grant



SYNOPSIS

Encouraged by the success of "Trial by Jury" Gilbert and Sullivan wrote "The Sorcerer" which first appeared in November 1877.

Alexis, the radically minded son of local Squire Sir Marmaduke Pointdextre, is to be betrothed to Aline, daughter of Annabella the Lady Sangazure – 'a lady of ancient lineage'- in whom Sir Marmaduke himself had taken more than a passing interest during his distant youth!

Alexis, firmly convinced that true love could break down all social barriers, has secretly engaged the services of a well known family sorcerer, one John Wellington Wells, to administer a love potion in the tea at the engagement celebrations to be attended by the whole village.

However, the composition of the love potion is such that on awakening from their induced sleep all will fall in love with the first person they see. This results in some comically disastrous liaisons involving Sir Marmaduke, Lady Sangazure, Dr. Daly the Vicar, the ancient Notary, the local church Pew-Opener Mrs. Partlet, and her love-struck daughter Constance, and all the village folk. Even the Sorcerer, John Wellington Wells, finds himself the object of some unwelcome amorous attention without having touched a drop.


As in all the best farces, however, the situation is resolved in time for the final curtain, when all the couples are re-united with their proper partners and the Sorcerer pays the penalty for his mischief making.
